## 6-MONTHLY FULLY SERVICED AGREEMENT

Thank you for the opportunity to become the Service Provider for your EnviroTas Aerated Wastewater Treatment System. Signing this agreement and entrusting us as your Service Provider ensures you are meeting the requirements of System Accreditation and your Plumbing Permit. We will lodge this signed and executed agreement with your local council.

### WHAT'S INCLUDED

An EnviroTas Wastewater Specialist will attend your property every six (6) months to service your EnviroTas Aerated Wastewater Treatment System. This is a comprehensive service that will ensure your system is operating effectively and within the standards set by regulatory authorities, including:

- Sight-check overall health and performance of the system.
- Check condition of all system pipework.
- Check system odour levels.
- Check sludge levels in each treatment chamber (if accessible).
- Check performance of aeration diffusers and adjust as required.
- Test/check operation of air blower.
- Test/check operation of discharge submersible pump.
- Measure dissolved oxygen levels.
- Measure pH.
- Clean irrigation filter.
- Check condition and performance of irrigation dispersion area.

Our specialist will record all information on a Service Certificate. You will receive a copy of this certificate for your records, and we will also lodge this certificate with your local council.

The cost of any failed system parts (except the electrical control panel) is also covered under this fully serviced agreement.

### WHAT'S NOT INCLUDED

Your service agreement does not cover the cost of labour for response to system breakdowns, parts failure, or system alarms. Our call out fee is \$160.00 + GST for the first hour (or part thereof), and any additional time is charged at \$112.00 + GST p/hour (excluding weekends and public holidays). All alarm calls should be directed to our office on 03 6234 7782. This number is monitored 24/7.

Your service agreement also does not cover the cost of replacement electrical control panels, any irrigation area repairs/maintenance, or the cost of a system de-sludge. The requirement for a system de-sludge is typically every 3-5 years. We will advise you in advance when this is required.
